PREAMBLE:

Government has approved the establishment of an industry for manufacture of luxury buses, small buses and light commercial vehicles (LCVs & VANs) and their parts and components by M/s. TATA Motors Ltd., Belur Industrial Area, Dharwad District with an investment of Rs. 2,044.00 crore vide Government Order read at (1) above.

In Government Order read at (2) & (3) above, Government has granted special incentives and concessions to M/s. TATA Motors Ltd., Belur Industrial Area, Dharwad District.

In the Government Orders read at (4), (5) and (6) above, Rs. 27,68,39,969/- released towards CST reimbursement to M/s. TATA Motors Limited, Mummigatti Post, Belur Industrial Area, Dharwad District, paid up to 5th June 2012 to March 2016, under Head of Account "2852-80-103-0-01(100)".

The Commissioner for Industrial Development and Director of Industries & Commerce has proposed vide his letter read at (7) above, to release the balance amount of CST reimbursement of Rs.10,87,29,910/- for the period from April 2016 to June 2017 to M/s. TATA Motors Ltd., Belur Industrial Area,

Dharwad District in the year 2018-19 under Head of Account "2852-80-103-0-01 (100)".

In the year 2018-19, Out of total budget allocation of Rs.300.00 Crore Rs.299.46 Crore has been released to the eligible industries. Therefore, there was budget deficit. Hence claims pertains to M/s. TATA Motors Ltd., Dharwad recommended vide letter read at (7) above could not be considered during the year 2018-19.

In the year 2019-20, Rs. 177.50 crore budgetary grants allocated (Out of total budget allocation of Rs.200.00 Crore, Finance Department vide BUDGET ADVICE dated 04.04.2019 restricted to Rs. 177.50 crore) for the scheme "Reimbursement Central Sales Tax (CST) to Eligible Industries " under the Head of Account 2852-80-103-0-01(100).

The pending Central Sales Tax (CST) reimbursement proposal Rs.10,87,29,910/- for the period from April 2016 to June 2017 of M/s. TATA Motors Ltd., Dharwad recommended from Commissioner for Industrial Development and Director of Industries & Commerce vide his letters read at (7) above submitted to Finance Department for releases from the allocation of grants under the scheme Head of Account 2852-80-103-0-01(100) during the year 2019-20.

Accordingly, Finance Department accorded it's concurrence vide note No. ಆಇ 156/ವೆಚ್ಚೆ-1/2019, dated 31.05.2019.

In the circumstances as explained in the preamble, Government is pleased to accord approval for the release of Rs. 10,87,29,910/- (Rupees Ten crore Eighty-seven lakh Twenty-nine thousand Nine hundred and Ten only) as the 95% of Central Sales Tax (CST) reimbursement for the period of April 2016 to June 2017 to M/s. TATA Motors Ltd., Belur Industrial Area, Dharwad District under Head of Account "2852-80-103-0-01(100) during financial year 2019-20".

M/s. TATA Motors Ltd., Mummigatti Post, Belur Industrial Area, Dharwad District is authorized to draw the amount on payee's receipt duly countersigned by Commissioner for Industrial Development and Director of Industries and Commerce Department.

This 95% of CST reimbursement is subjected to the conditions imposed in the Government Order No. CI 461 SPI 2010, dated 05.06.2012 and 03.09.2014.
