Preamble:

The project proposal of M/s. BKG Enterprises LLP to establish "IT and Hardware Park along with other supporting amenities with an investment of Rs.489.82 crore, generating employment of about 10000 persons in 35 acres of KIADB land at Sy.No 37,61,65,71,72,74,76,77,78 & 80 of Haralur Village, Channarayapatna Hobli, Devanahalli Taluk, Bengaluru Rural District was approved in 115th SLSWCC meeting held on 07.03.2019. Accordingly, Government Order read at (1) above was issued.

In the 126th SLSWCC meeting held on 08.10.2021 has approved extension of time to M/s. BKG Enterprises LLP to implement the project for a period of three years, with a condition that further extension of time will not be considered. Accordingly, Government Order read at (2) above was issued.

Now, the project proponent vide its letter dated 16.10.2024 has requested for Extension of time by 3 years to implement the project.
