



## **PROCEEDINGS OF THE GOVERNMENT OF KARNATAKA**

**Sub:** Approval to the proposal of M/s. Indian Cane Power Limited for expansion of "Ethanol production capacity from 60KLPD to 180 KLPD and Expansion of existing Captive Power Generation Plant from 2 MW to 9 MW using Bio Mass fuel, with 5 MW Exportable Power in their existing Distillery", at Duggavathi Village, Harapanahalli Taluk, Vijayanagara District.

### **Preamble:**

As per the decisions in the 197<sup>th</sup> SLSWCC meeting held on 09.06.2000, Government has accorded approval vide Office Order read at (1) above to the project proposal of M/s. Samsons Distilleries Private Limited to establish a manufacturing unit of "Rectified Spirit / Neutral Spirit" in 127 acres of land to be acquired by KIADB in Duggavathi & Kadathi Village, Harapanahalli Taluk, Davanagere District.

As per the Hon'ble High Court of Karnataka Order dated 14.08.2009, M/s. Samsons Distilleries Private Limited has amalgamated with M/s. Indian Cane Power Limited for their administrative convenience.

Now, M/s. Indian Cane Power Limited has proposed for expansion of "Ethanol production capacity from 60KLPD to 180 KLPD and Expansion of existing Captive Power Generation Plant from 2 MW to 9 MW using Bio Mass fuel, with 5 MW Exportable Power in their existing Distillery", with an investment of Rs. 121.07 crore, generating employment to about 114 persons located at Duggavathi Village, Harapanahalli Taluk, Vijayanagara District.

In the 106<sup>th</sup> Land Audit Committee (LAC) meeting held on 09.08.2023, the representative of the company appeared before the committee and highlighted the project proposal and requested for approval of the project.

The representative of the company also informed that Indian Cane Power Limited (ICPL) is a limited company registered on 1<sup>st</sup> March 2002. ICPL is promoted by Shri S. S. Mallikarjun, Director. ICPL proposes to expand their Ethanol production capacity from 60 KLPD to 180 KLPD in their Distillery unit located at Village Duggavathi Village, Harapanahalli Taluk, Vijayanagara District.

The Committee noted the request of the company and after detailed discussions, resolved to recommend to SLSWCC to accord approval for the project proposal of M/s. Indian Cane Power Ltd (Unit: M/s. Samsons Distilleries) for "Expansion of Ethanol production capacity from 60KLPD to 180 KLPD and Expansion of existing Captive Power Generation Plant from 2 MW to 9 MW using Bio Mass fuel, with 5 MW Exportable Power" within their existing unit located at Duggavathi Village, Harapanahalli Taluk, Vijayanagara District.

The proposal of the company was placed in the 140<sup>th</sup> SLSWCC meeting held on 15.09.2023, for discussions and decision. The committee noted the request of the company land utilisation details and after detailed discussion, resolved to approve the project proposal of M/s. Indian Cane Power Limited.

Government has examined the recommendations made by the SLSWCC in its 140<sup>th</sup> Meeting, in all aspects.

**GOVERNMENT ORDER No. CI 231 SPI 2023, BENGALURU, DATE 26.09.2023**

Government is pleased to accord **in-principle approval** to the investment proposal of M/s. Indian Cane Power Limited to expansion of Ethanol production capacity from 60 KLPD to 180 KLPD and Expansion of existing Captive Power Generation Plant from 2 MW to 9 MW using Bio Mass fuel, with 5 MW Exportable Power in their existing Distillery", with an investment of Rs. 121.07 crore, generating employment to about 114 persons located at Duggavathi Village, Harapanahalli Taluk, Vijayanagara District with the following infrastructure assistances, incentives and concessions:

<b>Land</b>	Within their existing unit located at Duggavathi Village, Harapanahalli Taluk, Vijayanagara District
<b>Water</b>	800 KLPD from the Thungabhadra River at the existing jack well at Vatlahalli Village, Harapanahalli Taluk, Vijayanagar District, subject to approval of Water Resources Department

<b>Power</b>	To export 5 MW power to KPTCL Grid at Kurubarahalli Sub Station and permission to export power under open access system, subject to approval from Energy Department
<b>Incentives &amp; Concessions</b>	As per applicable Policy of the State

**Sanction of the above infrastructure assistances, incentives and concessions is subject to the following terms and conditions:**

**1. Acknowledgement Certificate:** The project proponents may opt to furnish Combined Application Form (Form-4, Rule 8(b) along with relevant fee and self certification for issue of acknowledgment certificate under Karnataka Industries (Facilitation) (Amendment) Act, 2020.

**2. Environment:** The company to obtain Consent for Establishment and Consent for Operation from KSPCB and environmental clearance from MoEF, Govt. of India or the Dept of Forest, Ecology & Environment, Govt. of Karnataka, if applicable.

**3. Employment:** The Company shall comply with the provisions of applicable Policy of the State of Govt. of Karnataka with respect to local employment on the project. Prepare a plan for development of Human Resources required for the project, train local people. A copy of Human Resources Development plan shall be sent to the Commissioner for Industrial Development & Director of Industries and Commerce for monitoring.

**4. Vendor Development:** Wherever there is scope for vendor development for the project, the company shall prepare a vendor development plan, develop local vendors and procure the required inputs, components and sub-assemblies from these local vendor units. A copy of the vendor development plan shall be sent to the Commissioner for Industrial Development & Director of Industries and Commerce for monitoring.

**5. Social Infrastructure Development:** The Company is advised to take up social infrastructure development projects in the vicinity of the proposed location of the unit and comply with the stipulation of Company Act 2013. A copy of such projects shall be sent to the Commissioner for Industrial Development & Director of Industries and Commerce for monitoring.

**6. Others:**

- a. The company shall adopt rainwater harvesting, waste water recycling and water conservation techniques. Zero discharge facility should be adopted wherever applicable.
- b. The company shall take all statutory and other necessary clearances from the competent authorities including Govt. of India.

- c. As part of "Ease of Doing Business" Government vide order No. CI 89 SPI 2013, Dated: 20.12.2014 has accorded approval to operationalise e-Udyami Phase II for obtaining various clearances / approvals / licenses etc. through common e-platform for the projects approved through District Level Single Window Clearance Committee (DLSWCC) or State Level Single Window Clearance Committee (SLSWCC) or State High Level Clearance Committee (SHLCC) w.e.f. 01.01.2015.
- d. The approvals / NOCs of following Departments have been covered under Phase II of e-Udyami.

E-Udyami Phase II web application may be accessed through [www.ebizkarnataka.gov.in](http://www.ebizkarnataka.gov.in) and online application along with necessary documents may please be filed for any of above Departments' approval / NOCs.
- f. Karnataka Udyog Mitra (KUM) would provide the necessary escort services for the speedy implementation of your project. You are requested to inform the progress made in the implementation of the project every quarter in the proforma.
