



PROCEEDINGS OF THE GOVERNMENT OF KARNATAKA

Sub: Amendment to the earlier approved project proposal of M/s. KPR Sugar Mills Private Limited - reg.

Read:

1. Government Order No. CI 169 SPI 2011, dated 22.08.2011.
2. Government Order No. CI 225 SPI 2020(E), dated 19.09.2020.
3. Proceedings of the 148th State Level Single Window Clearance Committee (SLSWCC) meeting held on 26.09.2024.

Preamble:

The project proposal of M/s. KPR Sugar Mills Private Limited to establish a “5000 TCD white Crystal Sugar plant, 34 MW Co-gen Power Plant & 90 KLPD Molasses Processing Plant” with an investment of Rs.410.76 crore generating employment to about 347 persons at 318 acres (170 acres of own land to be converted by Deputy Commissioner, Bijapur and balance 148 acres of land to be acquired and allotted by KIADB as SUC on consent (70%) at various Sy. Nos. of Almel Village, Sindagi Taluk, Bijapur District was approved in the 25th State High Level Clearance Committee (SHLCC) meeting held on 14.07.2011. Accordingly, Government Order read at (1) above was issued.

In the 120th State Level Single Window Clearance Committee (SLSWCC) meeting held on 19.08.2020 has approved enhancement of capacity of Sugar Plant from 5000 to 10,000 TCD, Co-Gen from 34 to 40 MW and Distillery from 90 to 130 KLPD with an additional investment of Rs.33.82 crore, subject to no additional cane area allocation to M/s. KPR Sugar Mills Private Limited. Accordingly, Government Order read at (2) above was issued.

Status of Implementation:

Company has established 10,000 TCD Sugar Plant, 42 MW Co-generation & 130 KLPD Ethanol Plant in the year 2012-13 and successfully running since then.

Company so far has invested Rs.444.58crore and generated employment to about 510 Persons.

Now, the company in its letter has requested approval for expansion of Ethanol / Distillery Plant from 130 KLPD to 240 KLPD with an additional investment of Rs.40.00 crore generating employment to about 634 persons.

The company has submitted certification of registration in the name of M/s. KPR Sugar Mill Limited on 15.10.2024 and requested for approval of the project in this name.

Recommendation of the 114th Land Audit Committee (LAC) meeting held on 13.09.2024:

The Commissioner for Cane Development and Director of Sugars vide letter dated 13.09.2024 has provided the opinion as follows:

“This office has not yet received any proposal from the said factory till date. Once we receive the proposal from the factory, the same will be scrutinized and verified by this office. Till then it is requested that this proposal shall be postponed in the subject matter”.

The representative of the company appeared before the Committee and requested approval for expansion of Ethanol / Distillery Plant from 130 KLPD to 240 KLPD with an additional investment of Rs.40crore generating employment to about 634 persons and further informed that they have obtained for IEM for increase in capacity from 130 KLPD to 240 KLPD and increase in capacity is based on present approved crushing capacity. Hence new cane area allocation is not required as of now.

The Committee noted the request of the company and after detailed discussions resolved to recommend to SLSWCC for approval of the following:

1. Expansion of Ethanol / Distillery Plant from 130 KLPD to 240 KLPD with the present approved cane crushing capacity
2. Additional investment of Rs. 40.00 crore
3. Additional employment of about 634 persons

The proposal was examined & approved in the 148th State Level Single Window Clearance Committee (SLSWCC) Meeting held on 26.09.2024.
