Preamble:

The project proposal of M/s. Kaynes Electronics Manufacturing Private Limited (Formerly M/s. Kaynes Technology India Private Limited) establish a unit for "Electronic Assemblies, Box Build, Cable Harness, Electro Mechanical Assemblies" with an investment of Rs.49.80 crore in 6 acres of land in Immavau Industrial Area, Mysuru District was approved in the 118th SLSWCC meeting held on 12.12.2019. Accordingly, Office Order was issued.

In the 120th SLSWCC in its meeting held on 19.08.2020, the committee noted the action taken for the grant of an extension of time vide Office Order No. I&C/ID/SLSWCC/E5/2020-21, dated 06.07.2020 and, after detailed discussions, resolved to ratify the action taken. Accordingly, Office order read at (1) above was issued.

In the 129th SLSWCC in its meeting held on 21.2.2022, the government is pleased to accord approval to the investment proposal of M/s. Kaynes Technology India Private Limited to establish a unit for the manufacture of "Consumption Meters for Electricity, Water, and Gas, Flow Meters, and Counting Meters/Electronic Assembly" with an investment of Rs.35 crore and generating employment for approximately 390 persons. KIADB will allot 5 acres of land at Badanaguppe Kellamballi Industrial Area, Chamarajnagar District. Water requirement of 500 KLPD will be provided by KIADB, and 450 KVA of power will be supplied. Accordingly, Office order read at (2) above was issued.

In the 135th SLSWCC in its meeting held on 21.10.2022, the committee noted the request of the company and, after detailed discussions, decided to approve the transfer of approval from M/s. Kaynes Technology India Limited to Kaynes Electronics Manufacturing Private Limited, subject to the KIADB Transfer Policy in vogue. Accordingly, Office order read at (3) above was issued.

As per KIADB allotment letter No.KIADB/HO/Allot/Secy-1/22823/323/2021-22, dated 04.04.2022, 28,359 square meters (7.01 acres) of land in Plot No. 7 of Badanaguppe Ellamballi Industrial Area, Chamarajnagar District, was allotted to the company.

Now, the company has requested the consideration of the 118th and 129th approvals as a combined investment, totaling Rs.84.80 Crore. Additionally, they have requested permission to increase the total investment to Rs.480 Crore.

The company seeks approval for the inclusion of activities related to electronics assembly and the manufacturing of industrial consumer electronics, automotive components, railway equipment, medical devices, aerospace and defense systems, outer space technology, and IoT/IT products.

Recommendation of the 115th Land Audit Committee (LAC) meeting held on 28.10.2024:

The representative of the company appeared before the Committee and requested approval for consideration of the 118th and 129th approvals as a combined investment and inclusion of activity Electronics assembly and manufacturing of Industrial Consumer Electronics, Automotive, Railways, Medical, Aerospace, Defence & Outer space and IoT/IT.

The Committee noted the request of the company and after detailed discussions resolved to recommend to SLSWCC for approval of the following:

- Merger of two projects approved vide Government Order No. I&C/ID/SLSWCC/E5/2020-21, dated 06.07.2020 and No. I&C/ID/SLSWCC-129/DD8/2021-22, dated 21.2.2022 as a single project.
- To increase the total combined investment from Rs.84.80 crore to Rs.480 crore.
- Inclusion of Activity Electronics Assembly and manufacturing of Industrial Consumer Electronics, Automotive, Railways, Medical, Aerospace, Defence & Outer space and IoT/IT.
