Preamble:

In the 126th State Level Single Window Clearance Committee (SLSWCC) meeting held on 08.10.2021 has approved the project proposal of M/s. Kruthika Ferrous Industries Private Limited to establish "1 MTPA Beneficiation, 0.6 MTPA Pelletisation Plant with 5 MW Power Plant" with an investment of Rs.270 crore, generating employment to about 360 persons at Lachanakeri & Kunikere Villages, Koppal Taluk & District, Accordingly, Government Order read at (1) above was issued.

Now, the company in its request letter dated 04.11.2023 requested for time extension for 2 years as land acquisition for the project delayed to court case. The case was finally cleared on 11.08.2022 in favour of the company.

Now the company has taken up the construction of the compound wall and land development works. Hence company is requesting for 2 year time extension.

Recommendation of 108th LAC meeting held on 17.11.2023:

The representative of the company appeared before the Committee and requested for extension of time by 2 years to implement the project.

The Committee noted the request of the company and after detailed discussions resolved to recommend to SLSWCC for grant of extension of time by 2

years to implement the project, with a condition that further extension of time will not be considered.

Decision of the 141st SLSWCC meeting:

The Committee noted the request of the company, recommendation of Land Audit Committee and after detailed discussions resolved to grant extension of time by 2 years to implement the project, with a condition that further extension of time will not be considered.

Government has examined the recommendations made by the 141st SLSWCC meeting held on 28.11.2023 in all aspects.
