Preamble:

The project proposal of M/s. Balaji Wafers Private Limited to establish a unit for manufacture of "Wafers and Namkeen", with an investment of Rs. 251.25 crore, generating employment to about 7467 persons at Kanagal 2nd Phase Industrial Area, Belagavi District was approved in the 137th SLSWCC meeting held on 24.01.2023. Accordingly, Government Order was issued vide read at (1) above.

Once again company requested to change the location from Kanagala Industrial Area, Belagavi District to Mulwad Industrial Area, Vijayapura district, due to the non-development of land and it was taking too much time. The request was accepted and moved on file to approve the project for implementation in Mulwad and accordingly, the government order read at (2) above was issued.

Now, company vide letter dated 20.01.2024 has requested for change of location from Mulwad Industrial Area, Vijayapura District to Japanese Industrial Township, Vasanthanarasapura 3rd phase, Tumukuru District for faster implementation of project.
