The project proposal of M/s. Netlabs Global IT Services Private Limited for setting up of a “Data Center and IT Services” unit with an investment of Rs. 15.50 crore, generating employment to 500 persons at Aerospace SEZ Sector, Hitech Defence & Aerospace Park, Devanahalli, Bengaluru Rural District was approved in the 128th SLSWCC meeting held on 06.01.2022. Accordingly, Office Order was issued vide read at (1) above.
