Preamble:

The project proposal of M/s. Precot Meridian Limited to establish a unit for manufacture of "Hygiene and Medical Care Polyster, Viscos and Cotton based Non-woven Textile Products", with an investment of Rs.330.00 crore, generating employment to about 600 persons at Special Economic Zone for Textiles, Industrial area, Hassan was approved in the 26th SLSWCC meeting held on 09.11.2011. Accordingly, Government Order was issued vide read at (1) above.
