### **Preamble:**

The project proposal of M/s. Shanti Fomach Private Limited to establish a unit for "Manufacture & Machining of Ready to Assemble & Sub-assembled, Grey Iron & SG Iron Castings Components", with an investment of Rs.117.92 crore, generating employment to about 349 persons at Desura Village, Belagavi District was approved in the 144<sup>th</sup> SLSWCC meeting held on 27.02.2024 & 01.03.2024. Accordingly, Government Order read at (1) above was issued.

Now, the company vide its letter dated 03.10.2024 has stated that company has located the land at Sy. No. 383/7 (3 Acres 34 Guntas), 373/1 (1 Acre 20 Guntas 383/8 (2 Acre 32 Guntas) and 383/8 (3 Acre 27 Guntas) Approximately 11.825 Acres at Desura Village, Belagavi District.

The company informed, a copy of agreement to sale for Sy. No. 383/7 (3 Acres 34 Guntas) and 373/1 (1 Acre 20 Guntas) is uploaded and waiting for the final sale agreement in the next 15 days.

The company requested to change land Sy. Nos. from 15 Acres 43 Guntas of private land to be purchased at Sy.Nos. 205/1, 205/3, 205/4, 205/5, 205/6, 206/1, 206/2 & 206/3 of Desura Village, Belagavi District to 11.825 Acres of Sy. No. 383/7 (3 Acres 34 Guntas), 373/1 (1 Acre 20 Guntas 383/8 (2 Acre 32 Guntas) and 383/8 (3 Acre 27 Guntas) of Desura Village, Belagavi District.
