Preamble:

In the 143rd State Level Single Window Clearance Committee (SLSWCC) meeting held on 06.02.2024 has approved the project proposal of M/s. Sri Sai Basava Sugars Limited to establish a unit for "Expansion of Sugar Plant Capacity from 3500 TCD to 5000 TCD and Co-gen Plant from 15 MW to 30 MW and establishment of 200 KLPD Distillery to produce Ethanol/ENA by using C Molasses, B Molasses/Sugar Syrup & Grains (Multi feed) Plant" with an investment of Rs.498.41 crore, generating employment to about 250 persons at Malagan Village, Almel Taluk, Vijayapur District. Accordingly, Government Order read at (1) above was issued.

The project proponent vide letter dated 24.07.2024 has requested for the following:

1. Inclusion of additional activity of 20 TPD CBG Plant along with Spent Wash Spray Dryer Plant and 80 TPR Potash Granulation Plant in upcoming distillery Project.
2. Additional land of 20.33 acres to be acquired through KIADB as SUC in Sy. Nos. 71/1, 226/1, 218/6, 210/1, 101/1, 206/7 and 206/3 at Malagan Village, Almel Taluk, Vijayapur District.
