### **Preamble:**

The project proposal of M/s. Stelis Biopharma Private Limited for establishment of "Bio Therapeutics Products, Monoclonal Antibodies & Therapeutic Proteins" with an investment of Rs.248 crore, generating employment to about 125 persons at Doddaballapur Phase-3 Industrial Area, Bengaluru Rural District was approved in 38<sup>th</sup> State High Level Clearance Committee (SHLCC) meeting held on 17.06.2015. Accordingly, Government Order read at reference (1) was issued.

In the the 139<sup>th</sup> State Level Single Window Clearance Committee (SLSWCC) meeting held on 27.03.2023, has accord approval for change of Constitution & change of name from M/s. Stelis Biopharma Private Limited to M/s. Stelis Biopharma Limited subject to payment of Share dilution charges & withdrawal of writ petition filed in Hon'ble High Court of Karnataka and as per the terms and conditions of lease agreement of KIADB. Accordingly, Government Order read at reference (2) was issued.

Now, Project proponent vide letter dated 09.09.2024, has requested for change of name from M/s. Stelis Biopharma Limited to M/s. Onesource Specialty Pharma Limited.

### **Recommendation of the 114<sup>th</sup> Land Audit Committee (LAC) meeting held on 13.09.2024:**

The representative of the company appeared before the Committee and requested approval for change of company name from M/s. Stelis Biopharma Ltd. to M/s. Onesource Speciality Pharma Limited.

CEO & EM, KIADB an extent of 10 acres of land in Plot No.2-A of Obadenahalli Indl. Area has been allotted in favour of M/s. Stelis Biopharma Limited.

The request of the company has to be as per the norms of change in name of the company policy of the Board and subject to condition that,

original promoters should continue to hold minimum 51% shares in the newly formed company.

Stelis Biopharma Limited to M/s.
