### **Preamble:**

In the 134<sup>th</sup> State Level Single Window Clearance Committee (SLSWCC) in its meeting held on 03.09.2022 has approved the project proposal of M/s. Sundari Sugars Limited to establish "Sugar 4500 TCD, 24 MW Co-Gen Power & 200 KLPD Ethanol Plant", with an investment of Rs. 402.24 crore, generating employment to about 270 persons at Kampli Village, Kampli Taluk, Ballari District, Accordingly, Government Order read at (1) above was issued.

### **Status of implementation details:**

Following approvals received from various Government authorities;

1. Sugar Plant IEM 4500 TCD
2. Co-generation IEM 24 MW
3. Ethanol Plant IEM 200 KLPD
4. Consent to Establishment (CFE) from KSPCB
5. Application for water permission for 3000 KLPD

Now, the company vide its letter dated 10.10.2023 has requested for increasing water capacity from 3000 KLPD to 7000 KLPD.

### **Recommendation of 108<sup>th</sup> LAC meeting held on 17.11.2023:**

The representative of the company appeared before the Committee through V.C and requested for approval for increase in water requirement from 3000 KLPD to 7000 KLPD.

The Committee noted the request of the company and after detailed discussions resolved to recommend to SLSWCC for approval to increase water requirement from 3000 KLPD to 7000 KLPD from Tungabadra River, subject to approval of Water Resources Department.

The proposal was examined & approved in the 141<sup>st</sup> State Level Single Window Clearance Committee (SLSWCC) Meeting held on 28.11.2023.

Government has examined the recommendations made by the 141<sup>st</sup> SLSWCC meeting in all aspects.

Hence the following order.
