Preamble:

In the 134th State Level Single Window Clearance Committee (SLSWCC) in its meeting held on 03.09.2022 has approved the project proposal of M/s. Sundari Sugars Limited to establish "Sugar 4500 TCD, 24 MW Co-Gen Power & 200 KLPD Ethanol Plant", with an investment of Rs. 402.24 crore, generating employment to about 270 persons at Kampli Village, Kampli Taluk, Ballari District, Accordingly, Government Order read at (1) above was issued.

In the 141st State Level Single Window Clearance Committee (SLSWCC) in its meeting held on 28.11.2023 has approved the proposal of M/s. Sundari Sugars Limited to increase water requirement from 3000 KLPD to 7000 KLPD from Tungabhadra River, subject to approval of Water Resources Department. Accordingly, Government Order read at (2) above was issued.

Now, the company has requested 2 years extension of time for implementation of the project vide letter dated 16.09.2024.

Recommendation of the 115th Land Audit Committee (LAC) meeting held on 28.10.2024:

The representative of the company appeared before the Committee and requested approval for extension of time to implement the project.

The Committee noted the request of the company and after detailed discussions resolved to recommend to SLSWCC for approval of extension of time by 2 years to implement the project, with a condition that further extension of time will not be considered.

The proposal was examined & approved in the 149th State Level Single Window Clearance Committee (SLSWCC) Meeting held on 30.10.2024.
