Preamble:

The project proposal of M/s. Tata Advanced Systems Limited was accorded approval in the 148th State Level Single Window Clearance Committee (SLSWCC) meeting held on 26.09.2024 to establish a unit for "Aircraft Manufacturing - Final Assembly Line (FAL) including MRO (Rotary and Fixed Wing Aircraft and cater to Platforms using future technologies related to Vertical Lift such as electric propulsion, unmanned systems, etc.)", with an investment of Rs.500 crore, generating employment to about 80 persons at Phase-1 of Vemgal Industrial Area, Kolar District. Accordingly, Government Order read at (1) above was issued.

Now, the company vide letter dated 20.11.2024 informed that, they have already made 100% payment to KIADB towards land cost and waiting for the allotment letter.
