NO.CI 51 SGF 2010, BANGALORE, DATED:14.07.2014.

Whereas the draft of the Karnataka Sugar Services (Cadre and Recruitment) Rules, 2014, was published as required by clause (a) sub section (2) of section 3 of the Karnataka State Civil Services Act, 1978 (Karnataka Act 14 of 1990) in notification No.CI 51 SGF 2010, dtd: 29.05.2014 in part IV A(P.R.No.342) of the Karnataka Gazette dated:29.05.2014 Inviting objections and suggestion for all persons likely to be affected thereby within fifteen days from the date of its publication in the official Gazette.

Whereas, the said Gazette was made available to the public on 29<sup>th</sup> May 2014. However, no objections were received. The suggestions received in this behalf have been considered by the State Government.

Now, therefore, in exercise of the powers conferred by sub-section(1) of section 3 read with section 8 of the Karnataka State Civil Services Act, 1978 (Karnataka Act 14 of 1990) the Government of Karnataka hereby makes the following rules, namely:-

**RULES**

1. **Title and commencement:-** (1) These rules may be called the Karnataka Sugar Services (Cadre and Recruitment) Rules, 2014.  
 (2) They shall come into force from the date of their publication in the official Gazette.

2. **Method of recruitment and minimum qualification:-** The establishment of the Karnataka Sugar Services, shall consist of the categories of posts with the scales of pay specified in column (2) of the Schedule below, the number of posts, the method of recruitment and the minimum qualification, if any shall be as specified in the corresponding entries in columns (3), (4), (5) and (6) thereof.

3. **Repeal and savings:-** (1) The Karnataka Civil Service (Sugar Branch) Recruitment Rules, 1986, are hereby repealed:  
 Provided that the said repeal shall not affect, -  
 (a) The previous operation of the said rules or anything duly done or any action taken there under; or  
 (b) any right, privilege liability or obligation accrued or incurred under the said rules.
