Whereas the draft of the Karnataka Industries and Commerce Services (Recruitment) (Amendment) Rules, 2003 was published as required by sub-section (2) of section 3 of the Karnataka Civil Services Act, 1978, (Karnataka Act 14 of 1990) in notification No. DPAR 65 SRD 2002 dated 6-1-2003 in Part-IV-A of the Karnataka Gazette (Extra-ordinary) dated 6-1-2003 inviting objections and suggestions from all persons likely to be affected thereby within thirty days from the date of publication in the Official Gazette.

And whereas the said Gazette was made available to public on 6-1-2003.

No objections and suggestions have been received by the Government.

Now, therefore, in exercise of the powers conferred by sub-section (1) of section (3) read with section 8 of the Karnataka State Civil Services Act, 1978 (Karnataka Act 14 of 1990), the Government of Karnataka hereby makes the following rules, namely :-

Rules

1. **Title and Commencement.**-(1) These rules may be called the Karnataka Industries and Commerce Services (Recruitment) (Amendment) Rules, 2003.

2) They shall come into force on the date of their publication in the Official Gazette.

2. **Amendment of Schedule.**- In the schedule to the Karnataka Industries and Commerce Services (Recruitment) Rules, 2001, in the entries relating to the category of posts of "Assistant Director", at serial number 9, for the entries in columns (7) and (8), the following shall be substituted, namely:-

| <p>"Thirty percent by direct recruitment; Sixty percent by promotion from the cadre of Industrial Promotional Officers and Superintendents in the ratio of 5:2 Provided that a Superintendent shall work as Industrial Promotional Officers for a period of one year on the basis of seniority on his own pay; and Notwithstanding anything contained in sub-rule .</p> | <p>I. For Direct Recruitment.- Must be a holder of B.E. degree in any branch of Engineering or B.Tech or Masters Degree in Business Management. II. For Promotion.- (i) Must have put in a service of not less than five years in the cadre of Industrial Promotional Officer</p> |

(2) of rule 3 of the Karnataka Civil Services (General Recruitment) Rules, 1977, ten percent by promotion by selection from the cadres of Industrial Promotional Officer, Superintendent, Industrial Extension Officer, First Division Assistant, Stenographer who acquire higher qualification as prescribed for direct recruitment.

If no suitable candidate is available for promotion by selection, the posts earmarked under this category shall also be filled by direct recruitment.

The promotion by selection shall be made by a Departmental Selection Committee constituted by the State Government, on the basis of percentage of marks obtained in the qualifying examinations prescribed for direct recruitment:

If the percentage of total marks obtained by two or more candidates are equal, the order of merit shall be fixed on the basis of their age, the older in age being placed above the younger:

The suitability of the candidate for promotion by selection shall also be determined on the basis of the performance report for the last five years.

(ii) Must have put in a service of not less than twelve years in the cadre of Superintendent and must have worked as Industrial Promotional Officer for not less than one year on his own pay in addition to the period specified above. He shall be posted as Industrial Promotional Officer in accordance with the seniority in the cadre of Superintendents.

III. For promotion by selection:-

(i) Must be holder of B.E. degree in any branch of Engineering or B.Tech, or Masters Degree in Business Management.

(ii) Must have put in a service of not less than twelve years in any of the cadres of Industrial Promotional Officer or Superintendent or Industrial Extension Officer or First Division Assistant or Stenographer.
