NOTIFICATION

In exercise of the powers conferred by second proviso of sub section (2) of section 3 of the Karnataka State Civil Services Act, 1978 (Karnataka Act 14 of 1990), the Government of Karnataka hereby makes the following rules further to amend the Karnataka Industries and Commerce Services (Recruitment) Rules, 2001, namely:-

RULES

1. Title and commencement. - (1) These rules may be called the Karnataka Industries and Commerce Services (Recruitment) (Amendment) Rules, 2020

(2) They shall come into force from the date of their publication in the official Gazette.

2. Amendment of schedule. - In the Karnataka Industries (and Commerce Services (Recruitment) Rules, 2001, in the schedule,-

(i) in the entries, relating to the category of post of "Assistant Director" at Serial No. 9, under the heading "total number of posts", for the entries in column 3, 4, 5 and 6, the following shall respectively be substituted with effect from 23.12.2016, namely:-
