



## **PROCEEDINGS OF THE GOVERNMENT OF KARNATAKA**

**Sub:** Amendment to the earlier approved project proposal of M/s. Elest Private Limited - reg.

### **Preamble:**

The project proposal of M/s. Elest Private Limited has proposed to establish an “Electric Vehicle Manufacturing” Unit with an investment of Rs.471crore, generating employment to about 867 persons at Kottur, Belur Industrial Area of Dharwad District was approved in the 55<sup>th</sup> SHLCC meeting held on 21.12.2020. Accordingly, Government Order read at (1) above was issued.

Now, the Company in its letter dated 18.10.2024 requested the following amendments;

1. Extension of time period for implementation.
2. Inclusion of Affidavit-Based Clearance for expedited process.

### **Reasons/Justification for Amendment Request:**

**Obstruction Due to Landowner Disputes:** Work impediments due to disputes over farmers payment by KIADB. Obstructing the company to work at site.

**Affidavit-Based Clearance Inclusion:** Requested to streamline procedural clearances under challenging conditions.

### **Recommendation of the 116<sup>th</sup> Land Audit Committee meeting:**

The representative of the company again appeared before the Committee and informed that;

- They have already have made substantial investment for the project implementation till date.
- Project implementation was delayed due to farmers agitation on the land.

- They have placed orders and purchased required machineries, construction materials and also equipments

Hence, once again the representative of the company requested for extension of time to implement the project.

Further, the following report/opinion received from the Executive Engineer, KIADB Zonal Office, Dharwad vide email dated 25.11.2024 was placed before the Committee for discussion.
