### **Preamble:**

The project proposal of M/s. Kirti Oil Industries Private Limited to establish a "Oilseed Processing, Refined Edible Oil, De Oiled Cake" Unit with an investment Rs.61.47 crore, generating employment to about 41 persons at Sy. No.17 of Karjol Village, Vijayapura Taluk and District was approved in the 121<sup>st</sup> SLSWCC meeting held on 01.10.2020. Accordingly, Office Order read at (1) above was issued.

### **Status of Implementation of the Project:**

- Solvent Extraction Plant - Ready for trial production.
- Pulses Processing unit - 80% Civil Work Completed and order for Machinery is placed.

Now, the Company vide letter uploaded on 19.11.2024 requested approval for the following amendments:

1. Enhancement of investment from Rs.61.47 crore to Rs.123.00 crore.
2. Approval for additional land of 4.33 Acres situated at Sy. No. 397 of Karjol Village, Babaleshwara Hobli, Vijayapura District
3. Revision of Solvent Extraction Plant with Edible Oil Refinery capacity to 225000 MT/PA and Inclusion of Pulses Processing unit capacity of 50000 MT/PA.
4. Extension of by 2 years for implementation of the project.
5. Approval to grant Achor unit status and waiver of APMC cess for a period of 7 years.

### **Recommendation of the 116<sup>th</sup> Land Audit Committee meeting:**

The representative of the company appeared before the Committee and requested approval for enhancement of project cost, additional land, revision of Solvent Extraction Plant capacity and extension of time.

The Committee noted the request of the company and after detailed discussions resolved to recommend to SLSWCC for approval of the following:

1. Enhancement of investment from Rs.61.47 crore to Rs.123.00 crore.
2. Approval for additional land of 4.33 acres situated at Sy No. 397 of Karjol Village, Babaleshwara Hobli, Bijapur District which has already been purchased.
3. Revision of Solvent Extraction Plant with Edible Oil Refinery capacity to 225000 MT/PA and Inclusion of Pulses Processing unit capacity of 50000 MT/PA.
4. Extension of by 2 years for implementation of the project, with a condition that further extension of time will not be considered.

In the 150<sup>th</sup> State Level Single Window Clearance Committee (SLSWCC) meeting held on 06.01.2025 & 07.01.2025, the proposal of the Company was discussed and approved.
