Sub: Amendment to the earlier approved project proposal of M/s. Mysore Steels Limited - reg.

Read: 1. Government Order No. CI 55 SPI 2023, dated 22.02.2023.
2. Proceedings of the 150th State Level Single Window Clearance Committee (SLSWCC) meeting held on 07.01.2025.

Preamble:

The project proposal of M/s. Mysore Steels Limited to establish "Integrated Mixed Use project consisting of IT/ITeS/Hi-Tech Office, Residential and Commercial Space Project", with an investment of Rs.405.43crore, generating employment to about 200 persons at Belagola Industrial Area, Metagalli Village, Mysuru District was approved in the 137th SLSWCC meeting held on 24.01.2023. Accordingly, Office Order read at (1) above was issued.

Now, the Company vide letter dated 21.11.2024 has requested for extension of time by 4 years to implement the project.

Reasons /justification:

Company vide letter dated 21.11.2024, it is informed that, land consisted of a steel Plant, evacuation and shifting of plant and machinery, shifting by CHESCOM etc. consumes lot of time. Also, since the velocity of the project is quite substantial and the change in design and planning is also delaying the implementation of the project.

They are also parallelly under discussions with financial institutions and other stake holders. The recent regulations regarding e-Khatha by Government of Karnataka has also delayed documentation process.

Hence, the requested for extension of time by 4 years to implement the project.

Recommendation of the 117th Land Audit Committee meeting:

The representative of the company appeared before the Committee and requested approval for extension of time by 4 years to implement the project.

The Committee noted the request of the company and after detailed discussions resolved to recommend to SLSWCC for extension of time by 2 years to implement the project and based on the progress on implementation further extension of time will be examined/reviewed.

In the 150th State Level Single Window Clearance Committee (SLSWCC) meeting held on 06.01.2025 & 07.01.2025, the proposal of the Company was discussed and approved.

Government has examined the recommendations made by the SLSWCC in its 150th Meeting, in all aspects.
