Sub: Withdrawal of the earlier approved project proposal of M/s. Veer-Chemie & Aromatics Private Limited - reg.

Preamble:

The project proposal of M/s. Veer-Chemie & Aromatics Private Limited to establish a unit for manufacture of "Bulk Drugs, Intermediates, Fine Chemicals, & Specialty Chemicals", with an investment of Rs.167crore, generating employment to about 287 persons at Kadchur Industrial Area, Yadgir District was approved in the 144th SLSWCC meeting held on 27.02.2024. Accordingly, Government Order read at (1) above was issued.

Now, the Company vide letter dated 06.12.2024 has requested for cancellation of the project approved in the 144th State Level Single Window Clearance Committee (SLSWCC) meeting held on 27.02.2024.

Reasons /justification:

Company vide letter dated: 6.12.2024, it is informed that, Due to unavoidable reasons, they are unable to proceed with the project.

Hence, they have requested to cancel the Government Order bearing No. CI 132 SPI 2024, dated 12.03.2024 and also requesting to cancel the KIADB Demand Notice No. KIADB/HO/Allot/Sec-2/3709/2024-25, dated 24.05.2024.

Recommendation of the 117th Land Audit Committee meeting:

The Committee noted the request of the company and decided to recommend to SLSWCC for withdrawal of approval accorded in 144th SLSWCC meeting held on 27.02.2024 and vide Government Order No.CI 132 SPI 2024, dated 12.3.2024.

In the 150th SLSWCC meeting held on 06.01.2025 & 07.01.2025, the proposal of the Company was discussed and approved.

Government has examined the recommendations made by the SLSWCC in its 150th Meeting, in all aspects.
