### **Preamble:**

The project proposal of M/s. Wipro GE Medical Device Manufacturing Private Limited to establish a unit for manufacture of "Medical Equipment viz CT Scanner, Cat Lab, Ultra Sound, Patient Monitor, Anesthesia Unit Ventilator, ECG" unit with an investment Rs.109.20 crore, generating employment to about 31 persons at Plot No.4, Kadugodi Industrial Area, Whitefield, Bengaluru was approved in the 126<sup>th</sup> SLSWCC meeting held on 08.10.2021. Accordingly, Government Order read at (1) above was issued.

Now, the Company vide its application dated 29.10.2024 has requested for extension of time by 3 years to implement the project.

### **Reasons /justification:**

Company vide its application dated 29.10.2024, has informed that, Special Incentives scheme issued by GoK for ESDM Sector has an incentive for which they are eligible participant.

The scheme requires them to have the Single window Clearance during the time of incentive Claim. The scheme is applicable until 2027.

### **Recommendation of the 116<sup>th</sup> Land Audit Committee meeting:**

The representative of the company appeared before the Committee and requested approval for extension of time by 3 years to implement the project.

The Committee noted the request of the company and after detailed discussions resolved to recommend to SLSWCC for grant of extension of time by 3 years to implement the project, with a condition that further extension of time will not be considered.

In the 150<sup>th</sup> State Level Single Window Clearance Committee (SLSWCC) meeting held on 06.01.2025 & 07.01.2025, the proposal of the Company was discussed and approved.

Government has examined the recommendations made by the SLSWCC in its 150<sup>th</sup> Meeting, in all aspects.
