Sub: Amendment to the earlier approved project proposal of M/s. Rithwik Green Power and Aviation Private Limited - Transfer of approval from M/s. Rithwik Green Power and Aviation Private Limited to M/s. Win Innovations Space Private Limited – reg.

Preamble:

The project proposal of the M/s. Rithwik Green Power and Aviation Private Limited to establish a facility for “IT Park Project to cater to IT/ITeS and Hi-Tech Industries”, with an investment of Rs. 216.08 crore, generating employment to about 250 persons at Hitech Defence & Aerospace Park, Bengaluru subject to decision of Hon’ble High Court in pending W.Ps / W.As pertaining to Plot No 25-P1 was approved in the 143rd SLSWCC meeting held on 06.02.2024. Accordingly, Government Order read at (1) above was issued.

Now, the Company vide its letter dated 31.03.2025 has requested for Transfer of Approval from M/s. Rithwik Green Power and Aviation Private Limited to M/s. Win Innovation Space Private Limited.

Recommendation of 120th LAC meeting held on 02.05.2025:

The representative of the company appeared before the Committee and requested approval for transfer of approval from M/s. Rithwik Green Power and Aviation Private Limited to M/s. Win Innovations Space Private Limited.

CEO & EM, KIADB informed that the request of the allottee for transfer of approval has to be as per transfer policy of the Board subject to condition that, original promoters should continue to hold minimum 51% shares in the newly formed company.

The Committee noted the request of the company and after detailed discussions resolved to recommend to SLSWC for transfer of approval from M/s. Rithwik Green Power and Aviation Private Limited to M/s. Win Innovations Space Private Limited, as per transfer policy of the Board subject to condition that, original promoters should continue to hold minimum 51% shares in the newly formed company

In the 153rd SLSWCC meeting held on 27.05.2025, the proposal of the Company was discussed and approved.

Government has examined the recommendations made by the SLSWCC in its 153rd Meeting, in all aspects.
