



PROCEEDINGS OF THE GOVERNMENT OF KARNATAKA

Sub: Approval to the proposal of M/s Haldiram Snacks Food Private Limited to establish a unit for manufacture of "Potato Chips & Namkeen Products" at Vasanthanarasapura Industrial Area, Tumakuru District.

Preamble:

M/s Haldiram Snacks Food Private Limited has proposed to establish a unit for manufacture of "Potato Chips & Namkeen Products" with an investment of Rs.444.74crore, generating employment to about 295 persons at Vasanthanarasapura Industrial Area, Tumakuru District.

In the 121st Land Audit Committee meeting held on 01.07.2025, the representative of the company appeared before the committee and highlighted the project proposal and requested for approval of the project.

The representative of the company also informed that Haldiram Snacks Food Private Limited is incorporated on 13.12.2022. Haldiram Snacks Food Private Limited aims to stand today as one of the brand leaders in this highly sensitive market of Indian Snacks and Food Products.

The Committed noted the request of the company and after detailed discussions, resolved to recommend to SLSWCC to accord approval for the project proposal of M/s Haldiram Snacks Food Private Limited to establish a unit for manufacture of "Potato Chips & Namkeen Products" in 13.14 acres of sub leased land at "India Food Park", Vasanthanarasapura Industrial Area, Tumakuru District.

The proposal of the company was placed in the 154th SLSWCC meeting held on 08.07.2025, for discussions and decision. The committee noted the request of the company, land utilization details, recommendation of Land Audit Committee and after detailed discussions, resolved to approve the project proposal of M/s Haldiram Snacks Food Private Limited.

Government has examined the recommendations made by the SLSWCC in its 154th Meeting, in all aspects.

Hence the following order.

Government is pleased to accord in-principle approval to the investment proposal of M/s Haldiram Snacks Food Private Limited to establish a unit for manufacture of "Potato Chips & Namkeen Products" with an investment of Rs.444.74 crore, generating employment to about 295 persons at Vasanthanarasapura Industrial Area, Tumakuru District with the following infrastructure assistances, incentives and concessions:

Land	13.14 acres of sub leased land at "India Food Park", Vasanthanarasapura Industrial Area, Tumakuru District
Water	250 KLPD from KIADB
Power	2500 KVA from BESCOM
Incentives & Concessions	As per applicable Policy of the State
Eligibility of project for deemed clearance under Karnataka Industries (Facilitation) (Amendment Act, 2020)	The project proponents may opt to furnish Combined Application Form (Form-4, Rule 8(b) along with relevant fee and self certification for issue of acknowledgment certificate under Karnataka Industries (Facilitation) (Amendment) Act, 2020.

Sanction of the above infrastructure assistances, incentives and concessions is subject to the following terms and conditions:

1. Environment: The company to obtain Consent for Establishment and Consent for Operation from KSPCB and Environmental Clearance(EC) from Dept of Forest, Ecology & Environment, Govt. of Karnataka through <https://investkarnataka.co.inonline> portal and Environmental Clearance (EC) from MoEF, Govt. of India, if applicable.

2. Employment: The Company shall comply with the provisions of Applicable Policy of the State Govt. of Karnataka with respect to local employment on the project. Prepare a plan for development of Human Resources required for the

project, train local people. A copy of Human Resources Development plan shall be sent to the Joint Director, District Industries Center of concerned District and to the Commissioner for Industrial Development & Director of Industries and Commerce for monitoring.

3. Vendor Development: Wherever there is scope for vendor development for the project, the company shall prepare a vendor development plan, develop local vendors and procure the required inputs, components and sub-assemblies from these local vendor units. A copy of the vendor development plan shall be sent to the Joint Director, District Industries Center of concerned District and to the Commissioner for Industrial Development & Director of Industries and Commerce for monitoring.

4. Social Infrastructure Development: The Company is advised to take up social infrastructure development projects (CSR) in the vicinity of the proposed location of the unit and comply with the stipulation of Company Act 2013. A copy of such projects shall be sent to the Joint Director, District Industries Center of concerned District and to the Commissioner for Industrial Development & Director of Industries and Commerce for monitoring.

5. Others:

- a. The company shall adopt rainwater harvesting, waste water recycling and water conservation techniques. Zero discharge facility should be adopted wherever applicable.
- b. The company shall take all statutory and other necessary clearances from the competent authorities including Govt. of India.
- c. As part of “Ease of Doing Business” Government vide order No. CI 48 SPI 2019 Dated 29.09.2021 and CI 302 SPI 2022, Dated 14.02.2025 has accorded approval to integrate various clearances / approvals / licenses etc. through Single Window portal for the projects approved through District Level Single Window Clearance Committee (DLSWCC) or State Level Single Window Clearance Committee (SLSWCC) or State High Level Clearance Committee (SHLCC).
- d. The login and passwords which are used for filing application for in-principal approval (Phase I) are also applicable for KIADB services and for filing application for various clearances / approvals / licenses/ NoC's etc of various Departments (Phase II). Application may be accessed through <https://investkarnataka.co.in> and online application along with

necessary documents may please be filed for any clearances / approvals / licenses / NOCs etc.

- e. Karnataka Udyog Mitra (KUM) would provide the necessary escort services for the speedy implementation of your project. You are requested to update the progress made in the implementation of the project in your login on Single Window portal.

This approval is valid for a period of **two years** from the date of issue of this Government Order.
