



## **PROCEEDINGS OF THE GOVERNMENT OF KARNATAKA**

**Sub:** Amendment to the earlier approved project proposal of M/s G D Assets - reg.

**Read:** 1. Government Order No. CI 11 SPI 2021, dated 19.01.2021.

2. Proceedings of the 155<sup>th</sup> State Level Single Window Clearance Committee (SLSWCC) meeting held on 28.08.2025 & 29.08.2025.

### **Preamble:**

In the 122<sup>nd</sup> State Level Single Window Clearance Committee (SLSWCC) meeting held on 11.12.2020, Government has accorded approval to the investment proposal of GD Assets Private Limited to establish "Electronics Manufacturing Cluster" with an investment of Rs.487.20 Crore generating employment to about 16,000 persons in 153 Acres of land to be acquired by KIADB as SUC on consent of land owners at Sy. No. 13,14,15,16,17,18 & 19 of Doddatagali Village, Jadagenahalli Hobli, Hoskote Taluk, Bengaluru Rural District and Sy. No. 6 of Channigarayapura, Malur Taluk, Kolar District. Accordingly, Government Order read at (1) above was issued.

Now, the company vide letter dated 16.08.2025 has informed that they have applied to KIADB for land acquisition on 13.06.2022 & land acquisition is at preliminary notification stage, Hence company is requesting for extension of time by 3 years to implement the project.

### **Recommendation of 122<sup>nd</sup> LAC meeting held on 22.08.2025:**

The representative of the company appeared before the Committee and requested for approval of extension of time to implement the project.

Committee noted the approval accorded vide Government Order No. CI 11 SPI 2021, dated 19.01.2021, the order reads as follows,

"In-principal approval accorded to the investment proposal of M/s GD Assets Private Limited to establish "Electronics Manufacturing Cluster" with an investment of Rs.487.20 crore generating employment to about 1600 persons in 153 acres of land to be acquired and allotted by KIADB as SUC on consent of land owners at Sy. No. 13, 14, 15, 16, 17, 18 & 19 of Doddatagali village, Jadagenahalli Hobli, Hosakote Taluk, Bangalore Rural district and Sy. No. 6 of Chennigarayapura , Malur Taluk, Kolar District".

The Committee noted the amendment request of the company and after

detailed discussions resolved to recommend to SLSWCC for approval of the following:

1. KIADB to acquire and allot 153 acres of land situated at Sy. No. 13, 14, 15, 16, 17, 18 & 19 of Doddatagali Village, Jadagenahalli Hobli, Hosakote Taluk, Bengaluru Rural District and Sy.No.6 of Chennigarayapura, Malur Taluk, Kolar District under SUC with consent of land owners.
2. Extension of time by 2 years to implement the project, with a condition that further extension of time will not be considered.

The proposal was examined & approved in the 155<sup>th</sup> State Level Single Window Clearance Committee (SLSWCC) Meeting held on 28.08.2025 & 29.08.2025.

Government has examined the recommendations made by the SLSWCC in its 155<sup>th</sup> Meeting, in all aspects.
