



## **PROCEEDINGS OF THE GOVERNMENT OF KARNATAKA**

**Sub:** Project proposal of M/s Schneider Electric IT Business India Pvt. Ltd. to establish “EV chargers, All In Ones (AIO), Smart Line UPS, Variable Speed Drive, 3 Phase UPS, 3 Phase Battery Management System (BMS), PCBA, Smart UPS, Data centre racks, Rack power distribution units, and Chillers” at Jigani Village, JiganiHobli, Anekal Taluk, Bangalore Urban District.

### **Preamble:**

M/s. Schneider Electric IT Business India Pvt Ltd to establish “EV chargers, All in Ones (AIO), Smart Line UPS, Variable Speed Drive, 3 Phase UPS, 3 Phase Battery Management System (BMS), PCBA, Smart UPS, Data centre racks, Rack power distribution units, and Chillers” with an investment of Rs. 1520.75 Crore generating employment to about 550 persons in 47.19 acres of leased land along with 9,99,932 Sq.ft. of building at Sy.Nos.561/1, 569/1, 566/2, 537/1, 566/3, 568/3,569/2 at Thathannahalli Village, KasabaHobli, Anekal Taluk, Bangalore Urban District and 8.73 acres of leased land along with 1,54,000 Sq.ft. building at Sy.Nos.212, 217, 218, 231, 235 to 237, 241 to 246, 253 and 254 of Jigani Village, Jigani Hobli, Anekal Taluk, Bangalore Urban District.

### **Background of the company:-**

SEITB was incorporated on 10 March 1997 and is operating manufacturing facility in the state of Karnataka since 1998. The existing factory is a 5,42,790 sq. ft. facility and provides employment to around 2,400 people.

SEITB facility will have special emphasis on exports and almost the entire expanded capacity will serve the foreign markets which will strengthen its position as a reliable export hub for global customers. The existing plant is currently working with annual cumulative capacity of 9.4 lakh units p.a. for different products. Another expansion project which is under way will lead to an additional production of 9 lakh units p.a. For such project, Government Order (‘GO’) has already been received and it does not form part of the current proposal.

**Recommendation of 123<sup>rd</sup> LAC Meeting:**

The representative of the company appeared before the committee and highlighted the project proposal and requested approval of the project.

The representative of the company also informed that M/s Schneider Electric Private Limited was incorporated on 10 March 1997 and is operating manufacturing facility in the state of Karnataka since 1998. The existing factory is a 5,42,790 sq. ft. facility.

(BMS), PCBA, Smart UPS, Data centre racks, Rack power distribution units, and Chillers” in 47.19 acres of leased land along with 9,99,932 Sq.ft. of building at Sy.Nos.561/1, 569/1, 566/2, 537/1, 566/3, 568/3,569/2 at Thathannahalli Village, KasabaHobli, Anekal Taluk, Bangalore Urban District and 8.73 acres of leased land along with 1,54,000 Sq.ft. building at Sy.Nos.212, 217, 218, 231, 235 to 237, 241 to 246, 253 and 254of Jigani Village, JiganiHobli, Anekal Taluk, Bangalore Urban District.

In the 66<sup>th</sup> State High Level Clearance Committee (SHLCC) meeting held on 24.10.2025, the proposal of the Company was discussed and approved.

Government is pleased to accord in-principle approval to the investment proposal of M/s Schneider Electric IT Business India Pvt. Ltd. to establish “EV chargers, All in Ones (AIO), Smart Line UPS, Variable Speed Drive, 3 Phase UPS, 3 Phase Battery Management System (BMS), PCBA, Smart UPS, Data centre racks, Rack power distribution units, and Chillers” with an investment of Rs.1520.75 crore, generating employment to about 550 persons at Jigani Village, Jigani Hobli, Anekal Taluk, Bangalore Urban District with the following infrastructure assistance, incentives and concessions:

**Sanction of the above infrastructure assistances, incentives and concessions is subject to the following terms and conditions:**

**1. Environment:** The company to obtain Consent for Establishment and Consent for Operation from KSPCB and Environmental Clearance (EC) from Dept of Forest, Ecology & Environment, Govt. of Karnataka through <https://investkarnataka.co.in> online portal and Environmental Clearance (EC) from MoEF, Govt. of India, if applicable.

**2. Employment:** The Company shall comply with the provisions of Applicable Policy of the State Government of Karnataka with respect to local employment on the project. Prepare a plan for development of Human Resources required for the project, train local people. A copy of Human Resources Development plan shall be sent to the Joint Director, District Industries Center of concerned District and to the Commissioner for Industrial Development & Director of Industries and Commerce for monitoring.

**3. Vendor Development:** Wherever there is scope for vendor development for the project, the company shall prepare a vendor development plan, develop local vendors and procure the required inputs, components and sub-assemblies from these local vendor units. A copy of the vendor development plan shall be sent to the Joint Director, District Industries Center of concerned District and to the Commissioner for Industrial Development & Director of Industries and Commerce for monitoring.

**4. Social Infrastructure Development:** The Company is advised to take up social infrastructure development projects (CSR) in the vicinity of the proposed location of the unit and comply with the stipulation of Company Act 2013. A copy of such projects shall be sent to the Joint Director, District Industries Center of concerned District and to the Commissioner for Industrial Development & Director of Industries and Commerce for monitoring.

**6. Others:**

- a. The company shall adopt rainwater harvesting, waste water recycling and water conservation techniques. Zero discharge facility should be adopted wherever applicable.
- b. The company shall take all statutory and other necessary clearances from the competent authorities including Government of India.
- c. As part of "Ease of Doing Business" Government vide order No. CI 48 SPI 2019 Dated:29.09.2021 and CI 302 SPI 2022, Dated: 14.02.2025 has accorded approval to integrate the various clearances / approvals / licenses etc. through Single Window portal for the projects approved through District Level Single Window Clearance Committee (DLSWCC) or State Level Single Window Clearance Committee (SLSWCC) or State High Level Clearance Committee (SHLCC).

- d. The login and passwords which are used for filing application for in-principal approval (Phase I) are also applicable for KIADB services and for filing application for various clearances / approvals / licenses / NoC's etc of various Departments (Phase II). Application may be accessed through <https://investkarnataka.co.in> and online application along with necessary documents may please be filed for any clearances / approvals / licenses / NOCs etc.
